



Official Rules for the Wheel of Fortune Slot Promotion (the “Promotion”)

The Promotion will take place at YBR Casino & Sports Book, 800 West Genesee St., Chittenango, NY, 13037 (the “Promotion Site”) on April 15, 2025 from 11:00am to 4:00pm (while supplies last) (the “Promotion Times”) with the Grand Prize Drawings at 4:15pm (the “Drawing Time”). By participating, you agree to these Official Rules. The Promotion will take place at YBR Casino & Sports Book, 800 West Genesee Street, Chittenango, New York, 13037 (the “Promotion Site”) on April 15, 2025 from 11:00am to 4:00pm (while supplies last) (the “Promotion Times”) with the Grand Prize Drawings at 4:15pm (the “Drawing Time”). By participating, you agree to these official rules.

Eligibility. Participation is open only to adults who are at least 18 years old as of date of entry. Participants must be TS Rewards Members and use their TS Rewards Card to activate and participate in the Promotion. TS Rewards Cards are complimentary. Individuals with proper identification and who are at least 18 years of age may obtain a TS Rewards Card. Void where prohibited or restricted by applicable law.

How to Enter. The first two hundred (200) eligible participants to swipe their TS Rewards Card into a kiosk in the promotional area near one of the four (4) Wheel of Fortune Slot Machines located on the gaming floor at the Promotion Site during the Promotion Times will receive \$25 in Free Play to play five (5) COMPLIMENTARY \$5.00 wagers on the Wheel of Fortune Slot machines. Eligible participants will also receive a chance to spin the prize wheel and a drum entry into the grand prize drawing. Entries for the grand prize must be placed in the drum no later than 4:10pm. Participants may participate by coming to the promotional area on the gaming floor between 11:00am and 4:00pm (first-come-first-serve basis). At time of card swipe, participants will receive \$25 in Free Play which is only valid during the Promotion Times on the designated slot machines for the purpose of placing five (5) consecutive minimum bet (\$5.00) wagers. Upon completion of the five (5) minimum bet \$5 wagers, the participant will be able to cash out any remaining balance achieved. Cash balance after depletion of promotional Free Play is property of participant. Limit one entry per participant throughout the Promotion Times. By entering the Promotion, participants fully and unconditionally agree to be bound by these Official Rules and the decisions of Turning Stone, which will be final and binding in all matters relating to the Promotion.

Winning a Prize; Odds. Odds of receiving a Free Play for participation and the grand prize drawings depend on how many eligible guests are present during Promotion Times. Participation is limited to the first 200 eligible guests. The odds for the prizes on the prize wheel are: Merchandise (1:2). Five additional spins (1:4), 10 additional spins (3:16) or 15 additional spins (1:16).

Claiming Prize(s). The first two hundred (200) eligible participants to be present at the promotional area at the Promotion Site during the Promotion Times with their TS Rewards Card and valid ID will have the opportunity to receive a Free Play to participate in this Promotion, spin the prize wheel to win a prize and enter the grand prize drawing. All prizes are on first come, first served basis. Once a participant spins the wheel, the prize the wheel stops on will be awarded to the participant by the promotional staff. Any Free Play will be automatically added to the participant’s account and must be used during the Promotion Times at a Wheel of Fortune Slot Machine. Failure to use the Free Play prize within this timeframe or at a Wheel of Fortune Slot Machine will result in forfeiture of the Free Play prize. No compensation will be given for forfeited prizes.
