



Official Rules for the Super Ducky Dollars Hot Seat (the “Promotion”)

The Promotion will take place at YBR Casino & Sports Book, 800 W Genesee St, Chittenango, NY 13037 (the “Promotion Site”) on August 4, 2026, August 11, 2026, August 18, 2026 and August 25, 2026, from 4:00pm to 8:00pm (the “Promotion Times”), with drawings taking place at 4:00pm, 5:00pm, 6:00pm, 7:00pm, and 8:00pm (the “Drawing Times”). By participating, you agree to these Official Rules.

Eligibility. Participation is open only to adults who are at least 18 years old as of date of entry. Participants must be TS Rewards Members and use their TS Rewards Card to activate and participate in the Promotion. TS Rewards Cards are complimentary. Individuals with proper identification and who are at least 18 years of age may obtain a TS Rewards Card. Void where prohibited or restricted by applicable law. Team members, officers and executives of Turning Stone, including YBR Casino & Sports Book, Point Place Casino Hotel and The Lake House at Sylvan Beach, and its parent organizations, affiliates and sponsors, and their immediate family members (mother, father, sister, brother, husband/wife, son/daughter), are not eligible to enter the Promotion.

How to Enter. To enter the Promotion, eligible participants must demonstrate active slot or table play during the Promotion Times at the Promotion Site and be using their TS Rewards Card to be eligible to receive prizes awarded during the Promotion.

Prize(s). Five (5) cash prizes (cash prizes) will be awarded each promotional day during this Promotion (for a total of twenty (20) prizes to be awarded during the Promotion) valued at \$100, \$150, \$200, \$250 and \$300. One (1) winner total will be selected randomly at each Drawing Time to pick an oversized rubber duck and reveal a cash prize for a total of five (5) winners in the Promotion per promotional day. All prizes awarded during the Promotion are non-negotiable and non-transferable. Participants who receive a prize must use such prizes in accordance with any terms and conditions regarding such prizes. In the case of unavailability of any prize, Turning Stone Resort Casino reserves the right to substitute a prize of equal or greater value. All applicable taxes and unspecified charges or expenses are the sole responsibility of the prize winner(s).

Winning a Prize; Odds. Winners of the prizes are chosen in a random drawing from the active player database at the Promotion Site at each Drawing Time. Odds of winning a prize depend on how many eligible guests are actively playing slots or table games on the Promotion Site gaming floor while using their TS Rewards Card during the Promotion Times. One (1) winner will be randomly selected by a computer-generated report from the active player database at the Promotion Site on August 4, 2026, August 11, 2026, August 18, 2026 and August 25, 2026 at each of the Drawing Times to pick an oversized rubber duck and reveal a cash voucher valued at \$100, \$150, \$200, \$250 and \$300. Once a prize is selected, that prize will no longer be eligible to win on that promotional day. Limit one (1) winner per Drawing Time. Participants who satisfy all eligibility requirements in the designated seats will be eligible to win. By entering the Promotion, participants fully and unconditionally agree to be bound by these Official Rules and the decisions of Turning Stone, which will be final and binding in all matters relating to the Promotion.

Claiming Prize(s). Winner(s) will be notified by an announcement over the overhead speakers at the Promotion Site. The prize must be claimed at the TS Guest Services within 5 minutes of the announcement. Turning Stone will not be responsible for failure of a participant to hear their name. If the winner(s) fails to present within the 5-minute timeframe from when the announcement is made, a redraw will be conducted until prize(s) are claimed. No compensation will be given for forfeited prizes. Valid photo identification and a valid TS Rewards Card must be presented when claiming all prizes. All winners are required to prove eligibility. Winners may be required to complete Form 1099 for prizes won.

Release. Turning Stone and its parent organizations and affiliates shall not be liable for any injury or other harm related to or resulting from participating in the Promotion, claiming or using any prize(s). By entering the Promotion, each participant and winner releases and holds Turning Stone and its parent organizations, affiliates and sponsors, and each of their respective representatives, officers, executives, team members and agents, harmless from any and all claims, losses, damages, costs and



expenses of any kind in connection with the Promotion (including without limitation as a result of the acceptance, use of or inability to use any prize).

Voluntary Participation. Participation is voluntary. By participating in the Promotion and accepting any prize, each participant grants Turning Stone, or its designee, permission to use their name, picture/likeness, address (city and state), biographical information, voice recording and any statements made by such participant regarding the Promotion or its business operations for promotional or publicity purposes without notice, further permission or compensation.

Right to Cancel; Disqualification. Turning Stone reserves the right to modify or cancel the Promotion at any time without prior notice. Participants who do not comply with these Official Rules, or attempt to interfere or tamper with the Promotion in any way, will be disqualified.
