



Official Rules for the Monthly Birthday Promotion (the “Promotion”)

The Promotion will take place at YBR Casino & Sports Book, 800 W Genesee St, Chittenango, NY 13037 (the “Promotion Site”) and begins at 5:00pm on August 16, 2026 and ends at 8:00pm on August 16, 2026 (the “Promotion Times”), with drawings taking place on August 16, 2026 at 6:00pm, 6:30pm, 7:00pm, 7:30pm and 8:00pm. By participating, you agree to these Official Rules.

Eligibility. Participation is open only to adults who are at least 18 years old as of date of entry. Participants must be TS Rewards Members and use their TS Rewards Card to activate and participate in the Promotion. TS Rewards Cards are complimentary. Individuals with proper identification and who are at least 18 years of age may obtain a TS Rewards Card. Void where prohibited or restricted by applicable law. Team members, officers and executives of Turning Stone and its parent organizations, affiliates and sponsors, and their immediate family members (mother, father, sister, brother, husband/wife, son/daughter), are not eligible to enter the Promotion.

How to Enter. TS Rewards Members with an August birthday will receive a postcard regarding the Promotion that must be brought to the Promotion Site on August 16, 2026 between 5:00pm and 7:45pm, and placed in the promotional drawing drum located at the TS Guest Services. Postcard will include participant’s name and TS Rewards Card Number. Eligible postcard recipients are responsible for bringing their postcard to the Promotion Site and dropping it into the drum during the Promotion Times to be eligible to participate. YBR Casino & Sports Book is not responsible for the loss of or damage to a participant’s entry postcard. Limit one entry per participant.

Prize(s). There are nine (9) total prizes in the Promotion: two (2) winners of \$50 Free Play each at the 6:00pm drawing, two (2) winners of \$50 cash each at the 6:30pm drawing, two (2) winners of \$100 Free Play each at the 7:00pm drawing, two (2) winners of \$100 cash each at the 7:30pm drawing, and one (1) winner of \$500 cash at the 8:00pm drawing. All prizes awarded during the Promotion are non-negotiable and non-transferable. Participants who receive a prize must use such prizes in accordance with any terms and conditions regarding such prizes. In the case of unavailability of any prize, Turning Stone Resort Casino reserves the right to substitute a prize of equal or greater value. All applicable taxes and unspecified charges or expenses are the sole responsibility of the prize winner(s).

Winning a Prize; Odds. The winners of the prize(s) will be selected in a random drawing of entries from the Monthly Birthday drawing drum to receive prizes. The drawings will be held at 6:00pm, 6:30pm, 7:00pm, 7:30pm and 8:00pm on August 16, 2026 at the TS Guest Services at the Promotion Site. Odds of winning the prize(s) depend on the number of eligible entries in the Promotion. By entering the Promotion, participants fully and unconditionally agree to be bound by these Official Rules and the decisions of Turning Stone, which will be final and binding in all matters relating to the Promotion.

Claiming Prize(s). Winner(s) will be notified by an announcement over the overhead speakers at the Promotion Site. The prize must be claimed at the TS Guest Services within 5 minutes of the announcement. Turning Stone will not be responsible for failure of a participant to hear their name. If the winner(s) fails to present within the 5-minute timeframe from when the announcement is made, a redraw will be conducted until prize(s) are claimed. No compensation will be given for forfeited prizes. Valid photo identification and a valid TS Rewards Card must be presented when claiming all prizes. All winners are required to prove eligibility. Winners may be required to complete Form 1099 for prizes won.

Release. Turning Stone and its parent organizations and affiliates shall not be liable for any injury or other harm related to or resulting from participating in the Promotion, claiming or using any prize(s). By entering the Promotion, each participant and winner releases and holds Turning Stone and its parent organizations, affiliates and sponsors, and each of their respective representatives, officers, executives, team members, and agents, harmless from any and all claims, losses, damages, costs

Voluntary Participation. Participation is voluntary.
