



## Official Rules for the High Card Showdown Hot Seat (the “Promotion”)

The Promotion will take place at YBR Casino & Sports Book, 800 W Genesee St, Chittenango, NY 13037 (the “Promotion Site”) on September 19, 2026 from 6:00pm to 9:00pm (the “Promotion Times”), with drawings taking place at 6:00pm, 7:00pm, 8:00pm and 9:00pm (the “Drawing Times”). By participating, you agree to these Official Rules.

**Eligibility.** Participation is open only to adults who are at least 18 years old as of date of entry. Participants must be TS Rewards Members and use their TS Rewards Card to activate and participate in the Promotion. TS Rewards Cards are complimentary. Individuals with proper identification and who are at least 18 years of age may obtain a TS Rewards Card. Void where prohibited or restricted by applicable law. Team members, officers and executives of Turning Stone, including YBR Casino & Sports Book, Point Place Casino and The Lake House at Sylvan Beach, and its parent organizations, affiliates and sponsors, and their immediate family members (mother, father, sister, brother, husband/wife, son/daughter), are not eligible to enter the Promotion.

**How to Enter.** To enter the Promotion, eligible participants must demonstrate active slot or table play during the Promotion Times at the Promotion Site and be using their TS Rewards Card to be eligible to receive prizes awarded during the Promotion.

**Prize(s).** Two (2) winners total will be selected randomly at each Drawing Time (for a total of eight (8) winners in the Promotion) to pick a card from our deck of cards to win a cash prize. At the 6:00 pm drawing, each of the two (2) winners will pick a card and the winner who picks the higher card wins \$400 cash while the winner who picks the lower card wins \$200 cash, if they pick the same card, they both win \$300 cash. At the 7:00pm drawing, each winner will pick a card and the winner who picks the higher card wins \$600 cash, while the winner who picks the lower card wins \$400 cash, if they pick the same card, they both win \$500 cash. At the 8:00 pm drawing, each winner will pick a card and the winner who picks the higher card wins \$800 cash, while the winner who picks the lower card wins \$600 cash, if they pick the same card, they both win \$700 cash. At the 9:00pm drawing, each winner will pick a card, and the winner who picks the higher card wins \$1,000 cash, while the winner who picks the lower card wins \$800 cash, and if they pick the same card, they both win \$900 cash. All prizes awarded during the Promotion are non-negotiable and non-transferable. Participants who receive a prize must use such prizes in accordance with any terms and conditions regarding such prizes. In the case of unavailability of any prize, Turning Stone Resort Casino reserves the right to substitute a prize of equal or greater value. All applicable taxes and unspecified charges or expenses are the sole responsibility of the prize winner(s).

**Winning a Prize; Odds.** Winners of the prizes are chosen in a random drawing from the active player database at the Promotion Site at each Drawing Time. Odds of winning a prize depend on how many eligible guests are actively playing slots or table games on the Promotion Site gaming floor while using their TS Rewards Card during the Promotion Times. Two (2) winners will be randomly selected by a computer-generated report from the active player database at the Promotion Site on September 19, 2026 at each of the Drawing Times to play the card game. Participants who satisfy all eligibility requirements in the designated seats will be eligible to win. By entering the Promotion, participants fully and unconditionally agree to be bound by these Official Rules and the decisions of Turning Stone, which will be final and binding in all matters relating to the Promotion.

### **Claiming Prize(s).**

Winner(s) will be notified by an announcement over the overhead speakers at the Promotion Site. The prize must be claimed at the TS Guest Services within 5 minutes of the announcement. Turning Stone will not be responsible for failure of a participant to hear their name. If the winner(s) fails to present within the 5-minute timeframe from when the announcement is made, a redraw will be conducted until prize(s) are claimed. No compensation will be given for forfeited prizes. Valid photo identification and a valid TS Rewards Card must be presented when claiming all prizes. All winners are required to prove eligibility. Winners may be required to complete Form 1099 for prizes won.



**Release.** Turning Stone and its parent organizations and affiliates shall not be liable for any injury or other harm related to or resulting from participating in the Promotion, claiming or using any prize(s). By entering the Promotion, each participant and winner releases and holds Turning Stone and its parent organizations, affiliates and sponsors, and each of their respective representatives, officers, executives, team members and agents, harmless from any and all claims, losses, damages, costs and expenses of any kind in connection with the Promotion (including without limitation as a result of the acceptance, use of or inability to use any prize).

**Voluntary Participation.** Participation is voluntary. By participating in the Promotion and accepting any prize, each participant grants Turning Stone, or its designee, permission to use their name, picture/likeness, address (city and state), biographical information, voice recording and any statements made by such participant regarding the Promotion or its business operations for promotional or publicity purposes without notice, further permission or compensation.

**Right to Cancel; Disqualification.** Turning Stone reserves the right to modify or cancel the Promotion at any time without prior notice. Participants who do not comply with these Official Rules, or attempt to interfere or tamper with the Promotion in any way, will be disqualified.
