



Official Rules for Spooky Spinning Wheel of Winning Promotion (the “Promotion”)

The Promotion will take place at YBR Casino & Sports Book, 800 W Genesee St, Chittenango, NY 13037 (the “Promotion Site”). The Promotion begins at 6:00am on September 23, 2026 and ends at 9:00pm on October 23, 2026 (the “Promotion Times”). Drawings will take place on October 23, 2026 at 5:00pm, 5:30pm, 6:00pm, 6:30pm, 7:00pm, 7:30pm, 8:00pm, 8:30pm and 9:00pm (the “Drawing Times”). By participating, you agree to these Official Rules.

Eligibility. Participation is open only to guests who are at least 18 years old as of date of entry. Participants must be TS Rewards Members and use their TS Rewards Card to activate and participate in the Promotion. TS Rewards Cards are complimentary. Individuals with proper identification and who are at least 18 years of age may obtain a TS Rewards Card. Void where prohibited or restricted by applicable law. Team members, officers and executives of Turning Stone, including YBR Casino & Sports Book, Point Place Casino Hotel and The Lake House at Sylvan Beach, and its parent organizations, affiliates and sponsors, and their immediate family members (mother, father, sister, brother, husband/wife, son/daughter), are not eligible to enter the Promotion.

How to Enter. Eligible participants will earn one (1) entry into the Promotion for every 30 slot points or 150 table points earned during the Promotion Times. Use of TS Rewards Card during slot play or table play at the Promotion Site is required to earn an entry. Entries earned via slot play are automatically calculated. Entries earned via table play are calculated when rated table play has been completed and closed out at the table and will not be displayed if checked while table game rating is still open. Eligible participants can also receive one (1) complimentary entry each day of the Promotion, during the Promotion Times, by swiping their TS Rewards Card at any Promotional Kiosk at the Promotion Site and selecting the Promotional Complimentary Entry tab located on the “Offers” screen of the Promotional Kiosks. Promotional kiosks are located throughout the Promotion Site. Free entry will be automatically added to participant’s account upon selecting the Complimentary Entry tab. No wagers are needed to receive a complimentary entry and participants are limited to one (1) complimentary entry per day during the Promotion Times. Use of TS Rewards Card is required to earn a complimentary entry. Entries are only valid for the month in which they are earned and do not carry over to future promotional months.

Activation. Entries for the Promotion must be activated. Eligible participants must activate their entries into the Promotion within one hour of each Drawing Time (the “Activation Period”) by displaying active slot or table play while using their TS Rewards Card at the Promotion Site. Participants must activate entries for each promotional Drawing Time. Participants will continue to earn entries for any carded play during the Activation Period. Any entries earned by active slot play during the Activation Period will automatically activate into the drawings when earned. Entries earned by active table play during the Activation Period will be calculated and activated into the drawings upon closure of table rating.

Prize(s). A total of nine (9) prizes will be awarded throughout this Promotion. One winner will be announced at 5:00pm, 5:30pm, 6:00pm, 6:30pm, 7:00pm, 7:30pm, 8:00pm, 8:30pm and 9:00pm on October 23, 2026. Each eligible winner will have the opportunity to spin the prize wheel to determine which one (1) of the six (6) possible cash prizes they will receive. The prize wheel will consist of the following possible prizes: \$313 cash, \$404 cash, \$666 cash, \$999 cash, \$1,031 cash and \$1,313 cash. All prizes awarded during the Promotion are non-negotiable and non-transferable. Participants who receive a prize must use such prizes in accordance with any terms and conditions regarding such prizes. In the case of unavailability of any prize, Turning Stone Resort Casino reserves the right to substitute a prize of equal or greater value. All applicable taxes and unspecified charges or expenses are the sole responsibility of the prize winner(s).

Winning a Prize; Odds. One (1) winner will be selected in a random drawing of activated entries from the Promotion Site activated entry database held at each of the Drawing Times on October 23, 2026. Odds of being selected as one of the nine (9) total winners depend on the number of eligible activated entries in the Promotion at the applicable Drawing Time. Once selected, the odds of winning each cash prize on the prize wheel are \$313 (1:4), \$404 (1:4), \$666 (3:20), \$999 (3:20), \$1,031



(1:10) and \$1,313 (1:10) By entering the Promotion, participants fully and unconditionally agree to be bound by these Official Rules and the decisions of Turning Stone, which will be final and binding in all matters relating to the Promotion.

Claiming Prize(s). Participants selected will be notified by an announcement over the overhead speakers at the Promotion Site. The participant must report to the TS Guest Services at the Promotion Site within 5 minutes of the announcement. Turning Stone will not be responsible for failure of a participant to hear their name. If the selected participant(s) fails to present within the 5-minute timeframe from when the announcement is made, no redraw will be conducted. The chance to win shall be forfeited. No compensation will be given for forfeited chances/prizes. Valid photo identification and a valid TS Rewards Card must be presented when claiming all prizes. All winners are required to prove eligibility. Winners may be required to complete Form 1099 for prizes won.

Release. Turning Stone and its parent organizations and affiliates shall not be liable for any injury or other harm related to or resulting from participating in the Promotion, claiming or using any prize(s). By entering the Promotion, each participant and winner releases and holds Turning Stone and its parent organizations, affiliates and sponsors, and each of their respective representatives, officers, directors, team members and agents, harmless from any and all claims, losses, damages, costs and expenses of any kind in connection with the Promotion (including without limitation as a result of the acceptance, use of or inability to use any prize).
